at fixed exchange rates



exchange rates




% change between annual averages



% change in real GDP between years



% of GDP



## Real effective exchange rate of the Icelandic króna 1960-2003



## Gross national saving and fixed capital formation 1960-2004




Real yield on non-indexed bank loans and M3 as percent of GDP



